FALL 2025 COURSES

AJ 4 – CRIMINAL LAW I* (TICKET #TBD)

UNITS: 3, TRANSFERABILITY: UC and CSU

Examines the philosophical and historical development of U.S. law and constitutional provisions; defines and classifies crimes; introduces the student to legal concepts, legal research, and case law; examines law as a social force. C-ID: AJ 120.

BIOT 70 – INTRODUCTION TO BIOTECHNOLOGY* (TICKET #TBD)

UNITS: 3, TRANSFERABILITY: UC and CSU

Introduction to the field of biotechnology including history of its origin and development, survey of modern industrial applications and accomplishments, ethical considerations and career paths.

BIOT 70L - INTRODUCTORY BIOTECHNOLOGY LABORATORY* (TICKET #TBD)

Prerequisites: Prior completion of or concurrent enrollment in BIOT 70 UNIT: 1, TRANSFERABILITY: CSU

Introduction to common techniques and basic skills common to the biotechnology industry.

MATH 5 - MATHEMATICS FOR LIBERAL ARTS STUDENTS* (TICKET #TBD)

Prerequisites: Completion of Intermediate Algebra or appropriate placement based on multiple measures assessment process. Requisite Comment: A student should know how to factor polynomials and work with rational expressions; solve systems of linear equations in two and three variables; solve linear inequalities and linear equations; work with radicals, rational exponents and complex numbers; solve quadratic equations and inequalities; work with functions; perform algebraic operations with exponential and logarithmic functions; and use the basic principles of analytic geometry. Recommended Preparation: Concurrent enrollment in TU 301 strongly recommended. UNITS: 3, TRANSFERABILITY: UC and CSU

A survey of selected topics including the mathematics of finance, set theory, probability, statistics, logic, critical thinking and other selected topics.

MGT 5 – PERSONAL FINANCIAL PLANNING* (TICKET #TBD)

UNITS: 3, TRANSFERABILITY: UC and CSU

Covers the proper management of personal incomes and expenditures. Students examine their relationship with money, set personal goals and develop a plan to meet those goals based on the social, psychological and physiological contexts in which financial decisions are made. Also listed as ECON 5; credit given in either area, not both.

* PATHWAY COURSE: students are expected and strongly encouraged to take subsequent courses as part of the pathway later in the year.
