Technology Access and Equipment Checkouts

Irvine Unified School District (IUSD or District) students may require access to the internet and a technology device to support in-classroom learning activities and completion of assignments at home. IUSD carefully curates the educational software programs and tools that we use to ensure that they are safe, age-appropriate, and accessible from any device (personal or provided by your child's school). If your child does not have access to the technology they need for learning, IUSD will provide a device. Information about device checkout opportunities will be provided by your school. All device checkouts are subject to the equipment loan policies outlined below.

Parent/Guardian Acknowledgements

I understand that this school year, I may be presented with the option to check out a device for my student. Should I borrow a device from IUSD, I acknowledge I have read and agree to the terms of use listed below.

I have read and agree to comply with the IUSD Technology Acceptable Use Policy and related Board Policies.

I will take all necessary precautions to make sure that this equipment is kept safe from harm and/or theft. I will keep the equipment locked up and secure at all times when it is not in use.

I understand the equipment and all software contained therein shall only be accessed and used by the student for authorized District school work. The parent/guardian signing this form acknowledges that the student and family shall hold harmless the Irvine Unified School District for any unauthorized access to or inappropriate websites the student may access while using this equipment.

I acknowledge that the assigned equipment is the property of the Irvine Unified School District and I understand that I must return this equipment to the District immediately upon the occurrence of any of the following circumstances: (1) the end of my enrollment at the school that issued the device; (2) at the request of school or IUSD administration.

I understand that it is my responsibility to immediately report a theft of this equipment to the police, and that I will thereafter contact IUSD's Risk Management Department (949) 936-5267 with the Law Enforcement contact name and case number as soon as it is practicable.

I understand that it is my responsibility to immediately report the loss of or damage to the equipment to my school site administrator. I will not disassemble any part of the device, attempt any repairs, or contract a repair service to work on the device. I understand that I am responsible for the replacement cost of the device if damaged, lost or stolen while issued to me.

I understand that IUSD may offer me the opportunity to purchase non-refundable device insurance to provide coverage for accidental damage and theft. I understand that my child may be required to bring the device to school each day that he/she is on campus. I understand that it is my responsibility to take precautions to prevent damage to the device and to make sure that the device is fully charged and working properly at the start of each school day.

In permitting student use of such devices, the District assumes no liability for the loss or theft of the device, damage to the device, or its misuse by the student or another person.
